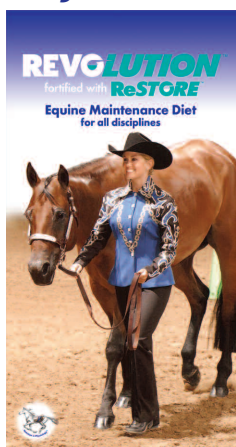

FEEDING DIRECTIONS

The amount of Revolution™ to feed will depend on body condition, activity level, forage quality and reproduction status. Typically the feeding rate of Revolution™ will be 4 to 6 lb per head daily. It is recommended that the amount fed each day be divided into 2 feedings. Revolution™ must be fed along with 1 to 2 lb of long stem hay (or equivalent pasture) per 100 lb of body weight.

If your horse requires additional feed to maintain the desired body condition, contact Biovance Life Sciences, Inc. at 877-246-7500.

La cantidad de Revolución™ para alimentarse dependerá de condición de cuerpo, nivel de actividad, calidad de forraje y estado de reproducción.

Típicamente el precio alimenticio de la Revolución™ será 4 a 6 libras por cabeza diariamente. Es recomendado esto la cantidad alimentada cada día ser dividido en 2 alimentaciones. La revolución™ debe ser alimentada junto con 1 a 2 libras del heno de tallo largo (o pasto equivalente) por 100 libras del peso de cuerpo.
