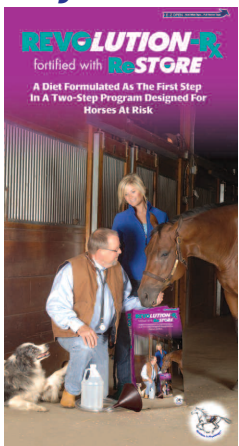

FEEDING DIRECTIONS

The amount of Revolution-Rx™ to feed will depend on body condition, activity level, forage quality and reproduction status.

Typically the feeding rate of Revolution-Rx™ will be 3 lb per head daily. Revolution-Rx™ is designed to complement most commercial feeds. It can therefore be substituted on a pound for pound basis. If the situation warrants, it can also be fed at recommended rates in addition to your current feed. It is recommended that the amount fed each day be divided into 2 feedings. Revolution-Rx™ must be fed along with 1 to 2 lb of long stem hay (or equivalent pasture) per 100 lb of body weight.

Espanol

Típicamente el nivel de entrada de la Revolución-Rx™ sea diario por cabeza de 3 libras. Revolución-Rx™ se diseña complementar las alimentaciones más comerciales. Puede por lo tanto ser substituido en una libra para la base de la libra. Si las autorizaciones de la situación, él se pueden también alimentar en las tarifas recomendadas además de su alimentación actual. Se recomienda que la cantidad alimentó cada día esté dividida en 2 alimentaciones. Revolución-Rx™ debe ser alimentado junto con 1 a 2 libras del heno largo del vástago o del pasto equivalente por 100 libras de peso corporal.
